## Birthday Party Contract

### SERVICE

iYooWee will provide the following:

- Qualified staff member who will serve as the tumble/games/dance/cheer instructor for the party
- Access to our facility for two hours

### FOOD

**iYooWee does not provide any food and/or drink items.** Guests may bring in cake, ice cream and snacks. All liquids must be a clear color. All food must be consumed inside the designated food area. Guests are also responsible for all eating and drinking utensils.

### PARTY AGENDA

First 45 minutes to an hour – Welcome, Introductions, Warm-up and tumble/dance/cheer instruction.  
Second hour – Opening of gifts, cake, and games.

### PAYMENT POLICY

A **\$125 payment** is due for parties of 12 guests or below at the time of booking.  
A **\$155 payment** is due for parties of 13 - 20 guests at the time of booking.  
A **\$175 payment** is due for parties of 21 – 30 guests at the time of booking.  
Larger parties may be discussed.

### CANCELLATION POLICY

Parties cancelled two weeks prior to the scheduled date will receive \$75 back. Parties cancelled less than two weeks prior to the scheduled date will not receive money back.

### BOUNCED CHECKS

iYooWee charges a \$25 fee for checks that are returned. All customers must be in good financial standing with iYooWee in order to host a party.

### CUSTOMER’S AGREEMENT
